

Procedure

1. When the foal is born, you fill in the Stallion Service Certificate and make a copy for yourself.

2. You fill in the I&R-form and attach the stallion service certificate to the original form;

3. You make an appointment with the veterinarian surgeon for micro chipping the foal;

4. You give the I&R-form to the veterinarian surgeon; he checks it and he completes it;

5. After micro chipping you ask the veterinarian surgeon to give the I&R-form back to you; if you don't ask it back, he will send it to another organization and your Welsh pony will not be registered with the WPCV;

6. You make a copy of the I&R-form for yourself and send the original form to the WPCV;

7. If you don't know the correct name of the markings, please have the veterinarian surgeon note this information;

8. For the costs of registration, please check our website (www.wpcv.nl/registration).

Microchipping: The foal needs to be haltered, free from dirt and presented on solid ground. Foals section A, B, C and D need to have an outline diagram (see above). For Welsh Partbreds an outline diagram is not necessary; there can be identified by 2 pictures taken from left/right side with the markings of all legs visible (on 1 picture the front of the head needs to be visible).

You have to apply for the passport not later than the foal is 3 months old and you have to pay promptly. After your payment has been received, the passport is produced. Your payment needs to be received within 6 months after the foal is born. Otherwise a passport with restrictions has to be issued (EU-rule). In that case the foal is not eligible to be slaughtered. The minimum age of microchipping a foal is 6 weeks old; the foal needs to be at the foot of the mare when it is chipped. SEND IN YOUR I&R-FORM NOT LATER THAN 7 DAYS AFTER MICROCHIPPING. TAKE CARE THAT YOU PAY IN TIME (see above) TO AVOID A PASSPORT WITH RESTRICTIONS.
