

Working method

- 1. Fill in the birth notice/decree (even if the foal is from own stallion x own mare).
- 2. Complete the I&R form and attach the original birth notification/decade.
- When the foal is at least 6 weeks old, you can have the foal chipped and apply for the passport.
 Contact a passport consultant or vet.
- On our website, you will find a list of passport consultants who chip for the WPCV.
- 5. The passport consultant charges a call-out fee and an insertion fee.
- 6. The production date of the passport must be within 9 months of the foal's date of birth.
- 7. If the production date of the passport is later than 9 months after birth, the foal will be excluded for human consumption.
- 8. The foal must be walking at the foot of the mare at the time of chipping.
- 9. Give the original form to the passport consultant or vet, who will check the form or complete it if necessary.
- 10. The passport consultant will take the I&R form and send the original to the WPCV registration office, or he will give it to you so that you can send it to the WPCV registration office within 7 days. If the vet has microchipped the foal, you must return the form and send the original to the WPCV registration office within 7 days.
- 11. Keep a copy of the birth notification/death certificate and the completed I&R form for your records.
